## **AUSTRALIA-EU RELATIONS**

### **Joint Statement from the 5th European Union – Australia Education and Training Policy Dialogue – Rethinking Education: challenges and opportunities released**

The Joint Declaration on Cooperation in Education and Training between the EU and Australia, signed in 2007, forms part of the EU-Australia Partnership Framework. The fifth European Union – Australia Education and Training Policy Dialogue was held in Melbourne on 4 March 2013.

Co-chaired by Mr Colin Walters, Head of the Australian Delegation and former Head of the International Education and Science Division of the Department of Industry, Innovation, Science, Research and Tertiary

Education (DIISRTE) and Mr Xavier Prats Monné, Deputy Director General of Education and Culture (DDG-EAC) at the European Commission, the 2013 dialogue concentrated on the challenges posed by globalisation and rapid technological advance for tertiary education with a particular focus on strategic partnerships, entrepreneurial and digital education to support careers of the future, and on qualifications.

Digital education has been identified as the topic of discussion for the sixth Dialogue to take place in November 2014.

**Australia’s Defence White Paper 2013: Future Uncertain?**

Location: RMIT City Campus Building 1, Level 2R, Council Chamber, Melbourne.

This event is presented by the European Union Centre at RMIT in conjunction with Curtin University’s Forum on National Security and Strategy.

The panel of speakers includes: Dr Alexey Muraviev, Head, Department of Social Sciences and International Studies, Curtin University. Captain Justin Jones, Director, Sea Power Centre -Australia RAN. Prof Joseph Siracusa,

Associate Dean, International and Justice Studies, RMIT. Dr Sanu Kainikara, Air Power Strategist, Department of Defence, RAAF. Mr Andrea Nicolaj, Counselor, Delegation of the European Union to Australia and New Zealand (TBC).

Australia’s latest Defence White Paper (DWP–2013), released on 3 May 2013, has received a mixed response. Compared with previous policy, the 2013 DWP articulates clearly the nation’s strategic appreciation of the Indo-Pacific concept and the need to adopt a ‘two oceans’ thinking and planning; it recognises the need to engage growing China rather than confront it; it places more emphasis on safeguarding the nation’s north-west, and offers other important developments.

The panel of eminent experts will provide unique insights into different aspects of the DWP–2013; some thoughts on issues to be addressed as the policy is refined and implemented. The speakers will offer a European perspective on the evolving Defence industry and the resources which it offers, academic analyses, and comment from a military perspective.

The European Commission is inviting bids for the final tranche of Marie Curie fellowship grants allotted under the current seventh Framework Programme for Research (FP7, 2007-13). Some €227 million, the highest single amount made available through the Marie Curie Actions fund, will be awarded to around 1000 experienced researchers this year.

The following two types of fellowships are open to non-European nationals:

- International Outgoing Fellowships (IOF) offer researchers the chance to acquire new knowledge in a high-level organisation outside Europe. As part of the grant agreement, the researchers have to return to Europe and share this knowledge.
- International Incoming Fellowships (IIF) enable researchers from outside Europe to be trained within a European institution.

Marie Curie individual fellowships support the mobility of researchers within and beyond Europe – as well as helping to attract the best foreign researchers to work in the EU. Individual fellowships will continue to be provided under the new Marie Skłodowska-Curie Actions as part of the Horizon 2020 programme, which starts in 2014.

### **EUROPEAN UNION ACADEMIC PROGRAMME HONG KONG (EUAP) — Research Assistant Professor (PR352/12-13)**

The EUAP is a consortium of four universities in Hong Kong (Hong Kong Baptist University, The University of Hong Kong, The Chinese University of Hong Kong and Lingnan University), co-financed by the European Commission. It is designed to strengthen EU-Hong Kong relations through academic work and enhance the understanding of the EU in Asia.
