Italian Elections 2013

In the lead-up to the Italian elections on 24 February 2013, viewed by some commentators as a defining factor for the future of the Eurozone, CESAA President and Associate Professor at Swinburne University of Technology, Bruno Mascitelli facilitated a Swinburne University of Technology hosted information session on the Italian vote overseas, providing a forum for the candidates of the Africa-Asia-Oceania-Antarctica electoral college to present their party's position and respond to audience questions.

The EU Centre at RMIT in conjunction with CESAA presented a public lecture on **Italy: Elections, economic crisis and Europe** on 19 February. At this event, CESAA President and Associate Professor at Swinburne University of Technology, Bruno Mascitelli introduced key players, outlined the importance of the coming election for Italy's future direction and discussed the implications in the broader European context.

Thomas Christiansen, Emil Kirchner and Philomena B. Murray (eds), *The Palgrave Handbook of EU-Asia Relations*, Basingstoke: Palgrave, 2013.

This edited book fills a gap in the literature on EU-Asia relations. The European Union and Asia are two regions undergoing significant changes internally while at the same time developing stronger relations with each other. In the context of an emerging multi-polar world, Europe and Asia are seen as major actors, making their relations increasingly crucial for the understanding of global politics. The Handbook is distinctive because it constitutes a thoroughly comprehensive collection of more than 40 contributions from a variety of disciplines and perspectives, bringing together leading authors in their respective fields. Contributors come from Europe, Asia, North America and Australia, thereby providing a genuinely global perspective on this important topic.

Simone Battiston, *Immigrants turned activists: Italians in 1970s Melbourne*, Leicester: Troubador Publishing Ltd, 2012.

This book offers a unique insight into the life trajectories of politically active Italian immigrants and their left-wing grassroots organisations. It does so in the light of fresh archival data and a string of oral accounts gathered from former and current members and collaborators of leading left-wing organisations, such as the Italian Federation of Migrant Workers and Their Families (FILEF). This study, which portrays successful pro-migrant lobbying as well as organisational failures and political sectarianism, is a telling example of the political potential and limits of immigrant activism in Australia.

Bruno Mascitelli and Sang-Chul Park, 'The impact of the Eurozone crisis on Australia and South Korea', *International Journal of Business and Social Science*, Vol. 3, No. 9 (May 2012), pp. 231-242.

The sovereign debt crisis affecting the Eurozone member states has both international economic and European integration significance. Rarely has a regional economic crisis had such clear and immediate effects on even

distant nations such as Australia and South Korea. The aim of this paper is to ascertain in what ways countries such as Australia and South Korea will feel the effects of the crisis. These are two different economic realities which theoretically should respond differently to this sovereign debt crisis. The paper also seeks to understand the similarities and the differences in the way these two nations will defend themselves from this economic tsunami and what factors will explain this economic defence.

Since 2009, the economic crisis has put pressure on national economies and labour markets all over the world, but the burdens are unequally distributed among different social groups. Young people are among those who tend to suffer most heavily from economic downturns. Many governments are launching various policy initiatives to tackle the severe consequences the crisis has had on youth labour markets. Depending on the institutional framework, these measures show diverse results for different groups of young people. As an integral part of labour market entry processes, such policies and their effects should be thoroughly understood.
