### **Recent Event: Democracy in Europe following the Italian Elections**

The EABC's objective is to promote trade and investment between Australia and Europe, and to connect business and policy-makers on issues affecting Australia's largest economic relationship.

#### **The Euro crisis: The long view**

Location: Molonglo Theatre, Level 2, JG Crawford Building 132, Lennox Crossing, Canberra, ANU

This lecture is presented by the Sir Roland Wilson Foundation, and supported by the Economics Society of Australia and Crawford School of Public Policy at The Australian National University.

Speaker: Professor Barry Eichengreen, George C. Pardee and Helen N. Pardee Professor of Economics and Professor of Political Science at the University of California, Berkeley, Research Associate of the National Bureau of Economic Research (Cambridge, Massachusetts) and Research Fellow of the Centre for Economic Policy Research (London, England), fellow of the American Academy of Arts and Sciences (class of 1997)

The euro crisis never seems to end. One reason why Europe is chronically unable to draw a line under its crisis is a failure to understand how it got into that crisis in the first place. In this lecture Professor Eichengreen takes a long view of events, starting with the birth of the European Union and advent of the euro and concluding with recommendations for resolving the crisis.

#### **Moving Beyond “Common Values and a Shared History”: Negotiating a Comprehensive Free Trade Agreement between Australia & Europe**

Location: ANU Centre for European Studies, 1 Liversidge Street (Bldg 67C), Canberra

Speaker: Alastair Walton, President of the European Australian Business Council. Chaired by Professor Margaret Harding, Deputy Vice-Chancellor (Research), Australian National University (ANU).

In his Robert Schuman lecture presented at the ANU in May 2012 Alastair Walton stated that Australia should continue to build on the momentum of a rapidly improving relationship with Europe by pursuing an ambitious bilateral agenda including the negotiation of a comprehensive Free Trade Agreement. This lecture identifies the historical importance of the free movement of labour and capital to the emergence of a modern

Europe but also to the fundamental underpinnings of the European Union itself. The European “continent of peace” has been built on the four freedoms of the internal market namely, the guarantee of the free movement of goods, capital, services, and people. These freedoms are intended to be conducive to increased competition, increased specialisation, larger economies of scale, allowing goods and the factors of production to move to those areas where they are most valued, thus improving efficiency of the allocation of resources. With the upcoming 100th anniversary of the commencement of World War I there is an opportunity to move beyond the rhetoric of “common values and a shared history” and acknowledge Australia’s military contribution to Europe’s freedom by negotiating a comprehensive FTA along the same lines as is currently being negotiated between Canada and Europe. This FTA would also act as a lever for the urgent and significant reforms which will be required for the Australian economy in the years ahead with the upcoming end to our booming terms of trade.

### **Fellowships/Scholarships**

#### **Marie Curie Actions**

**Closing date: The application process runs until 14 August 2013**

The European Commission is inviting bids for the final tranche of Marie Curie fellowship grants allotted under the current seventh Framework Programme for Research (FP7, 2007-13). Some €227 million, the highest single amount made available through the Marie Curie Actions fund, will be awarded to around 1000 experienced researchers this year.

The following two types of fellowships are open to non-European nationals:

- International Outgoing Fellowships (IOF) offer researchers the chance to acquire new knowledge in a high-level organisation outside Europe. As part of the grant agreement, the researchers have to return to Europe and share this knowledge.
- International Incoming Fellowships (IIF) enable researchers from outside Europe to be trained within a European institution.

Marie Curie individual fellowships support the mobility of researchers within and beyond Europe – as well as helping to attract the best foreign researchers to work in the EU. Individual fellowships will continue to be provided under the new Marie Skłodowska-Curie Actions as part of the Horizon 2020 programme, which starts in 2014.

## **Other funding opportunities**

### **European Union Australia Cultural Cooperation Partners 2013**

**Closing date: 8 May 2013**

The European Commission's Directorate General for Education and Culture has selected Australia as one of two Cultural Cooperation partners for 2013, (the other country is Canada). This means that European and Australian cultural organisations can submit joint proposals to take part in projects designed to promote cross-border cultural understanding.

Cooperation Projects aim to help cultural operators from participating European Countries such as theatres, museums, professional associations, research centres, universities, cultural institutes and public authorities to cooperate, so that different sectors can work together and extend their cultural and artistic reach across borders. Previous examples of such projects have ranged from promoting cultural dialogue through fashion, puppetry, and music, to photography festivals, literary projects, theatre and dance projects.

The European Union will co-finance up to half of the project costs to a maximum of €200,000 per project. Projects must involve three cultural operators from at least three different participating European countries, together with at least one organisation in Australia.

The deadline for applications is 8 May 2013 and successful applicants will be published on the results section on the website of the Executive Agency ([www.ec.europa.eu/culture](http://www.ec.europa.eu/culture)) on 31 August 2013. The starting date for successful projects is between 1 November 2013 and 31 October 2014, and the project duration is not more than 24 months.

## **Encounter: Australia-Europe— Ninth Round (2013)**

### **Closing date for the 9th round: 15 May 2013**

The Department of Industry, Innovation, Science, Research and Tertiary Education (DIISRTE) in conjunction with the European Union is calling for submissions for the 9th round of EU–Australia joint cooperation projects, opened by the European Commission on 14 December.

The 9th round projects are for commencement in 2013 and priority will be given to the development of EU–Australia joint degree projects from degree awarding institutions. The joint degree projects are of four years duration and provide support for Australian students to undertake study in Europe for an academic year. Submissions for other mobility projects are also invited from vocational education and training providers and degree awarding institutions.

The EU and Australia have long recognised the importance of academic cooperation and exchanges as a means to promote mutual understanding, innovation and quality of education with 2012 marking 50 years of partnership. The 9th round will be the second year that EU–Australia joint degrees have been offered emphasising the new phase of closer cooperation between the European Union and Australia.

The *Encounter: Australia-Europe* projects complement the ongoing EU–Australia Education and Training Policy Dialogues and facilitate new opportunities for collaboration.
