## Peter Halmai new president of the ECSA Hungary

Peter Halmai, professor and Researcher at the Department of International Economics of University of Pannonia (Veszprém, Hungary) has recently assumed the post of president of the Hungarian European Community Studies Association (ECSA Hungary).

Halmai succeeds Prof. Tibor Palánkai, director of the European studies and Education Centre at the Corvinus University of Budapest.

Prof. Palánkai, who has been in charge of the presidency for nearly two decades, received a Jean Monnet Prize from the European Commission in 2010. Prof. Halmai is specialized in the economics of the EU integration, economics of common policies and international economics. He has written over 189 scientific articles and 17 professional books.

The Hungarian ECSA vice presidents are now Dr. Ágnes Tuka (University of Pécs), Dr. Miklós Király (Eötvös Loránd University, Budapest) and Dr. Sándor Gyula Nagy (Corvinus University of Budapest).

## **Czech Republic ECSA**

The Czech Association for European studies (Czech Republic ECSA) initiated last year the organization of its annual conferences. The first one was held in Prague from 9 to 10 of November 2011 at the University of Economics in Prague with the title: *New Challenges for the European Union*. The participants were leading experts from 17 countries all over the world, including Prof. Enrique Banús, President of the ECSA-World. Conference involved the papers on topics related to European integration, politics, economics, law and other issues concerning the European Union.

In the framework of the Jean Monnet project on 12<sup>th</sup> April 2012 it took place a debate related to the topic 60 years of European Communities: from supranational project to its sub national implementation. The judge of the Court of Justice of the EU Prof. Jiri Malenovsky played a major part in the debate that was moderated by Jean Monnet Professor Nadezda Siskova. What is more, a round-table debate EU Law and German Constitucional Court was held on 9<sup>th</sup> of November 2012 at University of Economics in Prague, by Jean Monet Chair Prof. Rainer Arnold (University of Regensburg). This year Czech Republic ECSA also organized the meeting of the Executive board with the participation of others members of the association. It was celebrated on the 7<sup>th</sup> of July of 2012.

The association is planning as well for 2013 the second Annual Conference with the title *From Eastern Partnership to the Association – the Great Debate.* The conference will be held in May 2013 in Prague and is counting with the cooperation of the Ministry of Foreign Affairs of the Czech Republic, Karel Schwarzenberg, and the Faculty of Social Sciences Charles University.

Furthermore, the preparation of the first issue of the new periodical of the Czech-ECSA has recently started. This new Journal called *European Studies – Review of European Law, Economic and Political Science* will be edited in English by Wolter Kluwer publisher. The first issue is envisaged at the beginning of 2013. This scientific Journal edited once a year will bring the selected scientific articles in all branches of EU studies, the reviews of relevant books and information from the key conferences in the Czech Republic and abroad.

#### ECSA Canada presented

## "Europe in an Age of Austerity: Integration, Disintegration or Stagnation?"

The 9th Biennial Conference of European Communities Studies Association Canada (ECSA-C) entitled *Europe in an Age of Austerity: Integration, Disintegration, or Stagnation?* was hosted by Carleton University's Centre for European Studies and took place in Ottawa from April 26 to 28, 2012.

The conference explored how the EU and its member states deal with these challenges at a time when financial resources are scarce and invited researchers and practitioners from all over the world who study Europe from an economic, historical, legal, political, or sociological perspective to join us in Ottawa. Paper and panel proposals focused on all aspects of European integration, including continuity and change in European law, EU institutions and their relationship with the member states, democracy and political legitimacy, citizenship and identity, economic and social policy, among others. After the conference, some papers were awardwinner. The Best Student Paper Award was given to Dorottya Egerszegi from King's College London for her paper titled Corporate Lobbying in the Enlarged European Union. The Best EU Governance Paper was awarded to Ekaterina Turkina (HEC Montreal) and Kostas Kourtikakis (University of Illinois) for their paper Inter-Organizational Networks in the EU's External Relations with the Mediterranean and Post-Soviet States. Finally, the Best Overall Conference Paper was awarded to Amandine Crespy (Université Libre de Bruxelles) and Vivien Schmidt (Boston University) for their paper The Clash of the Titans/The White Knight and the Iron Lady: France, Germany and the Simultaneous Double Game of EMU Reform.

# Vice President of ECSA Russia appointed ambassador to Luxemburg

Professor Mark L. Entin, Vice President of ECSA Russia and a former director of the European Studies Institute at MGIMO University (Moscow State Institute of International Relations), has recently moved to Luxemburg to assume the post of Ambassador of the Russian Federation. Prof. Entin graduated in Law from MGIMO and later obtained the PhD in Legal Studies. Before assuming the directorship at the European Studies Institute he was director of the Institute of European Law at the same university. Before 2006 he already worked as a member of the diplomatic staff of the Ministry of Foreign Affairs of the Russian Federation. Mark Entin is Jean Monnet Chair and professor of Jean Monnet Center for European Studies at MGIMO-University. Vice President of ECSA Russia is the author of over 300 publications, including a series of monographs on European law and Russia-EU relations.

#### **ECSA Korea**

On 21 February 2012 the EU Studies Association of Korea (EUSA-Korea) celebrated it's annual conference at Yonsei University (South During this one-day event, three themes distributed in different sessions were discussed: the Samsung's Global Business Strategy Focused on the EU Market, Dynamics and Economic Nationalism in EU **Banking Market Integration** and the Real Convergence and European integration: Factors make the Difference in Growth at Regional Level?. The chair was Prof. Hee-Yul Chai of Kyonggi University and the three main speakers were Prof. Sang-Chul Park (Korea Polytechnic University), Dr. Hye-**Kyung Cho (Institute of Finance** and Economics) and Dr. Yoo-Duck Kang (KIEP: Korea Institute for International Economic Policy).

On the other hand, on the 7<sup>th</sup> of June it took place a Policy Seminar at Korea Cham-Commerce, (Korea). The aim of the seminar included a presentation of three papers and a panel discussion can be summarized in one theme: The Continuina Eurozone Crisis and Korea's Response. In addition, a twoday conference co-hosted and sponsored by KIEP and KIET (Korea Institute for Industrial Economics & Trade) was held at Gyeonggi College of Science and Technology of Korea on 7 and 8 of September. Besides, the association publishes the "Korean Journal of EU Studies" and the "Asia-Pacific Journal of EU Studies". Each journal is issued twice a year.

## ECSA Japan celebrated its 33<sup>rd</sup> Annual Conference

The European Union Studies Association-Japan held its 33<sup>rd</sup> Annual Conference in November 10 and 11 at Komaba Campus of the University of Tokyo. Among the 500 members of the association 150 attended the event.

The aim of this annual conference brings together academics and high-profile policy-makers to discuss the main aspects of *The EU as a Global Actor*.

Firstly, Prof. Toshiro Tanaka (Keio University) welcomed the conference and chaired the three first lectures: The European Union as a Global Actor: Focusing on the Field of Foreign and Security Policy, The Regulatory Power of the European Union- The Politics of Global Standardization and the EU Human Rights Diplomacy in a Globalized World. On the first day as well, there was another session composed of three more lectures: The European Union's Normative Power in a More Global Era, Austerity, the Euro-Crisis and EU's Diminished Profile in Global Security and EEAS- How EU Diplomacy is Taking Shape. This session was covered by Prof. Hiromasa Kubo of Kobe University.

On the last day, among the main questions considered were The Features and Impact of EU Free Trade Agreements, Territoriality and Demos in the European Polity and The Formation Process of the European Political Community Plan. Prof. Tamio Nakamura (Waseda University), Prof. Masami Kodama (Kurume University) and Prof. Machiko Hachiya (Kyushu University) chaired at three sessions on these lectures.

Finally, the topic of *The Euro Crisis and the EU Institutions* concluded the ECSA Japan annual's conference. It was discussed by four speakers and two discussants, chaired by Prof. Soko Tanaka of Chuo University.

The 34<sup>th</sup> annual conference will be held at Ritsumeikan University in Kyoto, in November 2013.

#### **ECSA Austria**

The European Community Studies Association of Austria (ECSA Austria) has organized during this year 2012 several activities in the capital of Austria, Vienna, and in the fourth-largest city in the country, Salzburg. Firstly in May association prepared two workshops and one seminar. The first workshop Distribution of Powers from Rome to Lisbon was celebrated in Salzburg on May 23<sup>rd</sup> and it was followed by the National Constiand EU tutions Integration workshop, held on the 10<sup>th</sup> and 11<sup>th</sup> in Vienna. On 14<sup>th</sup> and 15<sup>th</sup> of June a conference with the aim to discuss The Role of National Parliaments after Lisbon was presented in Salzburg.

On the other hand, a programme dedicated to *The European Constitution Post Lisbon* is expected to run in January 2013 and will comprised of the conference *Constitutional Courts and European Integration*, planned for the 13<sup>th</sup> and 14<sup>th</sup> of June in Salzburg.

Besides, there are also part of the programme the conference: Court Co-operation in the European Constitutional Compound Fundamental Issues and Latest Developments (which took already place on September 28 and 29 of 2012) and the Policy briefing seminar: The Lisbon Treaty and the Distribution of Power in the EU, held in Vienna in May 2012.
