National Parliaments in the EU “Composite Constitution”. The First Effects of the “Early Warning Mechanism”

Speaker: Professor Nicola Lupo – Department of Political Science, LUISS Guido Carli University, Italy director of a Master program in Parliament and Public Policies and of a Summer School on “Parliamentary Democracy in Europe”, member of the governmental advisory committee for Constitutional reform

Location: ANU Centre for European Studies, 1 Liversidge Street (Bldg 67C), Canberra

Parliaments of EU Member States (usually called “national parliaments”) are a numerous and very differentiated, composed of political institutions, each often with its own long history and traditions. The Treaty of Lisbon now confers new powers upon them, which can be exercised

for different aims and according to various formations. Specific attention has been given to the “early warning mechanism”, designed to effect the principle of subsidiarity, a crucial hub of the EU “composite Constitution”, which has been – correctly, it is argued – interpreted broadly, and which is showing its effects most of all in accelerating the process of the Europeanisation of the national parliaments.

21st annual workshop of the European Research Network on Transitions in Youth

The 21st annual workshop of the European Research Network on Transitions in Youth will be hosted by the research institute WZB (Wissenschaftszentrum Berlin für Sozialforschung). Since 2009, the economic crisis has put pressure on national economies and labour markets all over the world, but the burdens are unequally distributed among different social groups. Young people are among those who tend to suffer most heavily from economic downturns. Many governments are launching various policy initiatives to tackle the severe consequences the crisis has had on youth labour markets. Depending on the institutional framework, these measures show diverse results for different groups of young people. As an integral part of labour market entry processes, such policies and their effects should be thoroughly understood.

'SMART, SUSTAINABLE AND INCLUSIVE': Researching the EU from Australia and New Zealand

Cities Learning Together - Local Communities in the Sustainable and Healthy Learning City

Location: Hong Kong

In the spirit of learning partnerships this conference is organised by the European Union Centre at RMIT in conjunction with PASCAL and in partnership with the host, Hong Kong Institute of Education, with CITYNET, the

Society for Participatory Research in Action (PRIA), the Hong Kong United Nations Education and Vocational Training Centre (UNEVOC), the Asia Pacific Universities Community Engagement Network (APUCEN), the Asia South Pacific Association for Basic and Adult Education (ASPBAE) and the East Asian Forum for Adult Education (EAFEA).

The Conference will focus on present and future action, mainly within local neighbourhoods in big cities, to build green, safe, healthy, communities which are economically viable and sustainable. It will be structured so that there are interactive sessions on Days 1 and 3, and opportunities for field investigations in Hong Kong on Day 2.

The Conference will address the key questions around What works in different contexts around the world and why? What can be adopted and adapted between different regions, cultures and traditions, especially East and West, in this the 'Asian century'?

This will be a practically-oriented dialogue between European Union and older OECD approaches and those of East Asia and other non-EU regions. It will explore tensions, connections and syntheses between:

- Central policies and administration, and local, collaborative action, involving public, private, academic and civil society sectors;
- Economic growth and balanced social development;
- Short-cycle problem-solving and long-term action to contain and reduce global warming as aspirations and economic activity in the non-OECD world continue to outstrip those of the old West.

Fellowships/Scholarships

Marie Curie Actions

Closing date: The application process runs until 14 August 2013

The European Commission is inviting bids for the final tranche of Marie Curie fellowship grants allotted under the current seventh Framework Programme for Research (FP7, 2007-13). Some €227 million, the highest single amount made available through the Marie Curie Actions fund, will be awarded to around 1000 experienced researchers this year.

The following two types of fellowships are open to non-European nationals:

- International Outgoing Fellowships (IOF) offer researchers the chance to acquire new knowledge in a high-level organisation outside Europe. As part of the grant agreement, the researchers have to return to Europe and share this knowledge.
- International Incoming Fellowships (IIF) enable researchers from outside Europe to be trained within a European institution.

Marie Curie individual fellowships support the mobility of researchers within and beyond Europe – as well as helping to attract the best foreign researchers to work in the EU. Individual fellowships will continue to be provided under the new Marie Skłodowska-Curie Actions as part of the Horizon 2020 programme, which starts in 2014.

RMIT EU Centre International Visiting Fellowships 2013-14

Closing date: 30 August 2013

Applications for funding are now open under the RMIT EU Centre to assist an academic group attract an international leader from the European Union, expert in their field, to spend up to a month at RMIT to present lectures, seminars and/or other activities relevant to teaching, learning and research.

CAESIE Stage One Priming Grants

Closing date: 11 October 2013

Under the Stage One Priming Grants initiative, AU\$5,000 (approx. €4,000) support is available for small-to-medium enterprises (SMEs) in Australia and the European Union to develop a relationship with a researcher or research organisation (in the opposite region) through initial meetings and discussions focused on forming a relationship. To be eligible, SMEs should have identified a possible collaborative relationship with a researcher/research organisation partner. Assistance with finding a partner is available through the CAESIE Expression of Interest process.

Stage Two Priming Grants (AU\$5,000/approx. €4,000) may be available to successful Stage One applicants to formalise partnerships (e.g. further travel) and/or assist with applying for major research and development funds in Australia and Europe.

Connecting Australian-European Science & Innovation Excellence (CAESIE) is a bilateral partnership initiative between the European Union and Australia.

This initiative is specifically targeted to enhance science and technology collaborations between SMEs and researchers who focus on making a significant

contribution to addressing some of the world's grand challenges including:

- clean energy
- healthy ageing
- sustainable cities.

CAESIE offers:

- free assistance and brokerage to establish early stage collaborative links between researchers and SMEs in Australia and Europe, for knowledge exchange and research and development (R&D) product development.
- assistance with identifying government-funded programs and incentives in Australia and Europe for major project development and other opportunities for research and innovation.

CAESIE will explore Australian cooperation in research activities coordinated or networked among European Union member states and will provide information to support research-to-research links between Australia and the European Union.
