### **2014 European Union Studies Association Asia Pacific Conference — EU in the Shadow of Asia? Changing Relationships between the EU and the Asia Pacific**

Planning is under way for the 2014 EUSA AP conference, scheduled for 1–2 May 2014. The conference will focus on the changing relationship between the EU and the Asia Pacific. The discussion on the emerging powers of Asia is well established. However, there have been few Asia Pacific platforms where academics can present their research into how the concept of the coming century being one which pivots around Asia impacts on Asia Pacific – EU relations.

**27 November 2013 – 12.30–13.30**

**The virtuous circle of the welfare state: Is it valid any more?**

Speaker: Jouko Kajanoja, PhD (PolSc), Adjunct Professor Helsinki University. Dr Kajanoja has acted as senior researcher in The Government Institute for Economic Research and as chief of social research in The Social Insurance Institution in Finland

Location: Room 221/223, John Goodsell Building, University of New South Wales, Kensington

The underlying concept of the study is the virtuous circle. The core of the hypothesis is that the equality created by the welfare state is positively interrelated with social capital. Furthermore, it is argued that a high level of social capital results in a high level of wellbeing, resulting results in support for public social policy. Indicators from developed OECD countries to describe public social policy inputs, inequality, social capital and wellbeing were collected. The data cover the early 1990s, the turn of the millennium and the mid-2000s. Analysis of the data gives overall support to the hypothesis but casts doubt over the latest development. It seems that public inputs in social policy have no longer the same effect on inequality as they did before. Alternative (opposite) explanations why the virtuous circle seems to fail lately are sought. This leads a discussion about the possibilities and the roles of (comparative) research in explaining social development and support social policy.

#### Europe and Peace—10th Biennial Conference of the European Community Studies Association-Canada

Montreal, Canada

#### Closing date: 1 December 2013

The 2012 award of the Nobel Prize for Peace to the European Union provoked strong reactions, from the Wall Street Journal praising it as inspired to British politicians calling it preposterous and absurd.

The 10th Biennial Conference of European Communities Studies Association Canada (ECSA-C) will evaluate, measure and explain the EU's actual contribution to the advancement of peace and reconciliation, democracy and human rights. The conference intends to address both the EU's impact on the domestic politics of its member states, on its periphery and the world and to explore the role of EU institutions, but also member state governments, political, cultural and economic forces, and integration dynamics with the objective of providing a balanced assessment and analytical understanding of the EU's specific contributions (or lack thereof) to peace broadly understood. Papers on any topic related to the EU will also be welcome. Particular attention will be paid to the implications and lessons learnt of the European experience for other countries and regions, especially Québec, Canada and North America.

The organisation committee invites researchers and practitioners from all over the world who study Europe from an economic, historical, legal, political or sociological perspective. The two-and-a-half-day conference will include a plenary session, a professional development day for graduate students, panels, and workshops. Submissions for individual papers, panels with 3-4 paper presentations, and workshops with a dozen paper presentations are welcomed.

The deadline for submissions is 1 December 2013. Submissions, to be sent electronically to [ecsac@umontreal.ca](mailto:ecsac@umontreal.ca), can be written in English or in French. About 30 travel grants will be made available to graduate and postdoctoral students who are presenting a paper. Please indicate in your submission if you are requesting such a grant.

#### 27 – 28 November 2013

#### Bringing Australia and the EU Closer: Is an FTA the solution?

Location: ANU Centre for European Studies, 1 Liversidge St, Canberra

For the last twenty years Australia and the European Union have been seeking an enduring model for a closer intergovernmental and business relationship. Since October 2010 the two have been negotiating a treaty-level Framework Agreement, which would provide for closer cooperation and consultation across a range of policy areas. Specific commitments in trade policy are not, however, envisaged by either side. After more than three years these negotiations have not yet been finalised.

The EU has recently sought Free Trade Agreements with many of Australia's major Asia-Pacific and OECD trading partners. These 'new generation' FTAs aim to go beyond border measures such as tariffs. Proposed liberalisations extend to 'behind the border' regulatory barriers impacting on trade in both goods and services. At the same time, prospects for revitalising the Doha Round of multilateral trade negotiations are not bright.

Given these realities and the importance of the EU as a trading partner for Australia, is it time to explore an FTA between the EU and Australia?

This conference brings together current knowledge on Australia-EU trade relations and recent negotiating experiences of both parties in order to examine issues and prospects for an EU-Australia FTA. It examines opportunities that such an agreement could offer and probes the priority issues for both sides. It identifies key barriers that FTA negotiations would need to overcome for benefits to be realised. Particular attention will be given to recent negotiations between the EU and Canada for a 'Comprehensive Economic and Trade Agreement' – now close to completion – as a point of comparison with Australia, given similarities in interests and trade profiles.

#### Cities Learning Together - Local Communities in the Sustainable and Healthy Learning City

Location: Hong Kong

In the spirit of learning partnerships this conference is organised by the European Union Centre at RMIT in conjunction with PASCAL and in partnership with the host, Hong Kong Institute of Education, with CITYNET, the Society for Participatory Research in Action (PRIA), the Hong Kong United Nations Education and Vocational Training Centre (UNEVOC), the Asia Pacific Universities Community Engagement Network (APUCEN), the Asia South Pacific Association for Basic and Adult Education (ASPBAE) and the East Asian Forum for Adult Education (EAFAE).

The Conference will focus on present and future action, mainly within local neighbourhoods in big cities, to build green, safe, healthy, communities which are economically viable and sustainable. It will be structured so that there are interactive sessions on Days 1 and 3, and opportunities for field investigations in Hong Kong on Day 2.

The Conference will address the key questions around What works in different contexts around the world and why? What can be adopted and adapted between different regions, cultures and traditions, especially East and West, in this the 'Asian century'?

This will be a practically-oriented dialogue between European Union and older OECD approaches and those of East Asia and other non-EU regions. It will explore tensions, connections and syntheses between:

- Central policies and administration, and local, collaborative action, involving public, private, academic and civil society sectors;
- Economic growth and balanced social development;
- Short-cycle problem-solving and long-term action to contain and reduce global warming as aspirations and economic activity in the non-OECD world continue to outstrip those of the old West.
