### **Formation of the Juncker Commission**

On 22 October Members of the European Parliament approved the new college of Commissioners, as presented by its President-elect Jean-Claude Juncker, with 423 votes in favour, 209 against and 67 abstentions. The new Commission now needs to be formally appointed by EU heads of state or government to enable it to take up duty on 1 November for a five-year term.

### Herman Van Rompuy's farewell speech

In his farewell speech on 24 October, current President of the European Council Herman van Rompuy, whose term of office will end at the end of November, said that he had tried to act in the name of the European. According to Van Rompuy while it was not always "in one go", and sometimes with a "bit of pulling and shoving", it had been shown that a Union with twenty-eight countries can work.

He also stated that he had tried to show that the Union's institutions could work together, that they served the same cause, Europe's cause, and ultimately that of the

well-being of all Europe's citizens. He directed particular thanks to the outgoing President of the European Commission, José Manuel Durão Barroso for that achievement

#### Do Globalisation studies have a future?

Speaker: Professor A.G. Hopkins, Emeritus Smuts Professor of Commonwealth History, University of Cambridge; previous Smuts Chair, 1994-2001; Emeritus Fellow of Pembroke College; Professor of Economic History, University of Birmingham, 1977–1988; 1988–1994: Professor of History, University of Geneva; 2002–2013: Walter Prescott Webb Chair of History, University of Texas at Austin

Globalisation envelops the world - and historians too. The 'g' word is now mandatory in titles of books and articles; PhD students follow their leaders in dedicating their dissertations to the subject. Yet, not so long ago postmodern approaches to the past were equally compelling: if you could not tell your trope from your alterity and your Spivak from your Bhaba, your chances of landing a job were minimal. Wise investors buy at the bottom of the market and get out at the top. So, it is worth asking whether shares in globalisation have further to run or whether full value is already in the market. One way of answering the question is by considering the reasons why historiographical phases, like empires, rise, flourish and decline. This approach provides pointers to the current state of globalisation studies and offers an estimate of the current value of the shares. The advice comes with a wealth warning; past performance has limited predictive power. As a famous trumpeter remarked when asked which way jazz was going: 'Man, if I knew which way jazz was going, I would be there already!'

Most of all, cybersecurity issues affect us as individuals. We face new questions in everything from our rights and responsibilities as citizens of both the online and real world to simply how to protect ourselves and our families from a new type of danger. And, yet there is perhaps no issue that has grown so important, so quickly, and that touches so many, that remains so poorly understood.

# Trilingual Talk in Sicilian-Australian Migrant Families: Playing Out Identities Through Language Alternation

Speaker: Dr Antonia Rubino, University of Sydney

Trilingual Talk in Sicilian-Australian Migrant Families, organised by: Italian Cultural Institute in collaboration with: Department of Italian Studies, University of Sydney, is an in-depth study of the linguistic dynamics among Sicilian migrants in Australia, one of the largest regional groups in the context of Italian emigration. Through conversations gathered within the family, language choice and language alternation among Sicilian, English and Italian are explored in talk between first and second generation. The analytical approach combines the interactional with the language and identity perspective, focusing on code-switching as a strategy to construct and contest conversational and social identities. A corpus of quantitative surveys and other Sicilian-Australian voices gathered through interviews complement conversational data, contributing to the representation of the linguistic and cultural identities of Sicilian migrants. The study is placed in the context of the family migrant experience and the shifting attitudes towards immigrant languages in Australia.

# Sydney Ideas - The Philosophy of Pictorial Modernism: Hegel and the History of Painting

Speaker: Prof Robert B. Pippin, Evelyn Stefansson Nef Distinguished Service Professor, Committee on Social Thought, Department of Philosophy, the College, University of Chicago; winner of the Mellon Distinguished Achievement Award in the Humanities; fellow, American Academy of Arts and Sciences; member, American Philosophical Society

Co-presented with the Department of Philosophy and the Sydney Intellectual History Network at the University of Sydney

In his Berlin lectures on fine art in the 1820s, Hegel made two famous and very controversial claims. The first was that the content of fine art, religion and philosophy was essentially the same, and the second was that all the fine arts had become for us a "thing of the past," no longer an important vehicle of human self-knowledge. The "modern" art that Hegel considered was early nineteenth century romantic art. He died in 1831, and so did not witness the most revolutionary change in the history of arts, what we now loosely call "modernism."

This lecture concentrates on modernist painting and asks about the bearing of both Hegel's general approach to the meaning of art, and of his historical and diagnostic analysis, to modernist pictorial art. One version of the basic question would be: what should Hegel, given his philosophical and aesthetic commitments, have said about the achievement and historical significance of Édouard Manet's revolutionary paintings of the 1860's, generally credited with being among the first modernist paintings? Or, what sort of crisis in the credibility of conventional painting was modernist experimentation responding to, and what would it mean to consider these issues as being of philosophical significance?

Horizon 2020, the new EU Research and Innovation program, is a Europe 2020 flagship initiative aimed at securing Europe's global competitiveness. Funding is based on competitive calls open to everyone, also to

organisations/individuals outside the EU. Participants from countries associated to the EU research framework program have the same rights as EU participants; for other countries, the situation varies. Funding in the 2014 budget is focused on the three key pillars of Horizon 2020:

- Excellent Science: Around €3 billion, including €1.7 billion for grants from the European Research Council for top scientists and €800 million for Marie Skłodowska-Curie fellowships for younger researchers (see MEMO/13/1123).
- Industrial Leadership: €1.8 billion to support Europe's industrial leadership in areas like ICT, nanotechnologies, advanced manufacturing, robotics, biotechnologies and space.
- Societal challenges: €2.8 billion for innovative projects addressing Horizon 2020's seven societal challenges, broadly: health; agriculture, maritime and bioeconomy; energy; transport; climate action, environment, resource efficiency and raw materials; reflective societies; and security.
